*Description:* The GSA Treasurer will serve as the chair of the Finance Committee.

*Finance Committee:*

- Provost did confirm a list at the 10/30 forum. The list is still changing; just because your program is listed DOES NOT mean your program is being cut, but rather at risk. If your program is cut, you will still be allowed to finish your degree in what's called a "teach-out," however, any prospective students WILL NOT be able to enroll in the program. Final decision will be made in January/February.
- Another forum with Chancellor Gilliam on **November 28 from 2-3:30 pm** discussing the APR. There is also a "Chancellor Chat" on **November 6 from 12-1 pm**.
